FROM A MINISTER ~ Rev. Mark Ferrier

Each year, we come to another milepost in our covenant relationship as minister and pastoral charge of The United Church of Canada. In a recent email, someone noted that anniversaries like birthdays are good things—the more you have, the longer you live! Looking through an annual report is one way to reflect on the life and ministry we have shared in 2015 with all of its challenges and accomplishments in covenant with the God whom we know in Jesus the Christ.

It is also a reminder that above all, we are called to be people of faith, seeking to follow the way of Christ in all that we are and do—not simply here within the walls of buildings called churches, but in our relationships as people of faith and in the service we offer as our thankful response to Christ's presence in our lives.

Looking back over 2015, there have been the inevitable changes in St. Paul's. We have mourned for beloved family members and dear friends who died this past year. We have celebrated the birth of children and weddings. A new Birthday Sunday, Anniversaries, Coffee and conversation, shared meals have gathered us in at table to get to know one another and have those vital conversations that build relationships.

The ladies have laughed at the Petrolia Play House at another production about a UCW like group. We have worked together through the Community Kitchen to cook a good meal on Saturdays through the fall and winter to extend a helpful and welcoming ministry for all who need a good meal to stretch the budget. We have generously supported the Mission and Service Fund of the United Church of Canada with over \$31,000 in donations. Building refurbishment on the manse and maintenance have been done. A new tenant has rented the manse building and we look forward to having a good, long relationship to our mutual benefit.

We also face challenges as our core group of leaders needs to grow in numbers and to share in leadership of our congregations in partnership with our church staff. What do we need to preserve and take forward and what can we leave behind? Are there new initiatives we might try out?

For me, ministry is a solitary and a communal activity. There are the times of quiet conversation and pastoral care, personal reflection and prayer, as well as the projects and planning and carrying out of things. It is at times being out front in visible leadership and at others, in the background supporting others who are giving their best.

There has been opportunity to exercise leadership within Oxford Presbytery and London Conference in this time of transition in our denomination; and, there will be opportunities in 2016 to make decisions around the kind of change we are willing to support through our responses to remits.

I offered leadership last spring in the local Ministerial's Lenten series as a preacher and host, and at the recent Ostrander Funeral Home's Memorial Service just before Christmas.

It has been good to share this with fellow staff members: Shelley, Floyd, Ron, Karen, Helen and Maurice. After a full year on the job, I have found Helen to be a great support and capable in many things in the Office. Shelley has given us beautiful music and led our choir well. Ron and Floyd keep our buildings in good order in partnership with our Property Committee. Karen has come through her health challenges and has given a renewed commitment to plan and lead our children on Sunday mornings and at special day camps on school Professional Activity days. And Maurice, who decided to really retire and embrace the freedom that gives—I have truly appreciated his care of our elders and shut-ins and his partnership in ministry over these last nearly 3 years.

So I come to this milepost marked 2015 with gratitude, and with an eye to the good things we need to work on together in the coming year, to add good to the good that we have received, from God, the source of our being and strength and song.

FROM OUR PART-TIME MINISTER ~ Rev. Maurice Francis

As most readers know I will have retired from my part time appointment with St. Paul's at the end of the year 2015. That means I no longer receive a 4 hour a week stipend as was the case over the past 3-4 years. However one wishes to be clear that this does not mean we are leaving Tillsonburg or St. Paul's. Unless we get asked to leave and that has not happened to date and we trust may never happen in our life time.

Otherwise the year 2015 has not been unlike most previous years. I have visited home bound folk in their private homes as well as in places of Assisted Living, like Maple Manor, Woodingford Lodge in Tillsonburg, Caressent Care in Courtland and Woodstock. Our last resident in Terrace Lodge Aylmer, finished her journey there this past Summer.

We have met occasionally with folk at the Retirement Centre but most of our members requiring assistance are resident at the new Harvest facility on the East Side of town. Nine was the count. This is different from the time when we would visit folk in as many as 20 places and towns outside of T'burg. Thus the main reason for reducing our efforts in visiting.

Ruth and I have lead worship at Maple Manor, Woodingford and more recently at Harvest for more than 12 years. But serving communion 2-3 times a year has been our main contact with people in these situations.

It is our hope that we will continue to share these opportunities with Rev. Mark Ferrier, Full Time Minister and Rev. Pat Cook where time and need are indicated. Rev. Pat and I are now Officially Volunteer Associate Ministers.

It has been a privilege and sense of fulfillment to help out at St Paul's over the years. I wish once more to say my sincere gratitude to the Council and Congregation for the kind and generous testimony and gift extended to Ruth and

I on December 13, and for the many cards and gifts at Christmas. We will still try to follow the directive of Psalm 100:2. "Serve the Lord with gladness". Merci beaucoup.

CHURCH COUNCIL ~ Submitted by Brian Clark, Chair

As always, 2015 brought it's share of challenges and successes.

We held a number of musical concerts, the Choir gave us Cantatas to lift our spirits, the Sunday School Christmas program delighted us and our Worship Services brought us closer to God through Communion, inspiring messages from the pulpit and uplifting music from our Choir.

We have lived our Christian ministry through a variety of Outreach programs to the community including our Community Kitchen, our PD Day programs and the use of St. Paul's facilities for a number of programs from the community. We assisted our sister church at St. John's Anglican Church by sharing our building and facilities while they conducted a major renovation to their own building.

We enjoyed social fellowship through the Card Parties that Jed Drew has continued after Glenn and Cheryl Buchner coordinated them for a number of years.

Late in the year, we were all reminded of how blessed we have been to live in Canada as we watched the first refugees from the war in Syria arrive in Canada to begin a new life here. As this story continues to unfold, St. Paul's may be able to play a supporting role as Oxford Presbytery has plans to sponsor a family in Woodstock.

The Congregation showed courage and confidence by approving a program of repairs to the exterior of the vacant Manse property. The full details are included in the Trustees Report but the costs were significant at a time when we had no revenue from the property and ongoing expenses. Jed Drew led this project with support from the Trustees and the Council. When the project was completed we had a building that had been restored on the exterior, cleaned up inside and was now appealing to prospective tenants. Jerry Koza acted as the Real Estate agent and located a suitable tenant. In December, we successfully signed a 5 year lease with the owner of the Cup and Cake Restaurant.

As you will read in the Finance Committee report, our financial condition at the end of the year was sound and with the lease for the Manse becoming effective on January 1, 2016, we will no longer need to carry the expenses of the vacant property and will begin to receive rental income from it.

In December, Rev. Francis officially retired from our Staff but will continue to serve as a Voluntary Associate Minister. Over many years, Rev. Maurice Francis and his wife, Ruth have enriched St. Paul's through their joint ministry of calm and effective service. We have benefited greatly and we wish them continued joy and good health for many years.

I want to thank all of the members of St. Paul's and the Council for your support for the Church this past year and for me as your Chair. Working together as a team, we have accomplished much this year.

In closing, let me remind you that we cannot know for certain what lies ahead in 2016. I expect that the New Year will bring it's own share of challenges for St. Paul's Congregation. But we can be confident that God is leading us into a future that is already filled with His Goodness.

The Worship Committee is responsible for the Spiritual interests of the congregation. One of the main areas of oversight pertains to the Sunday worship service. On a weekly basis, Doreen Smith arranges for ushers, Sam Helsdon for greeters, and Mary Beard for readers.

Shelley Vermeersch, organist and choir director arranges for choir music and soloist as well as special presentations. This year the St. Paul's Community Choir presented the Christmas Cantata *Beautiful Star.*

The committee members organize the servers for our Communion service which take place the First Sunday of Advent, Christmas Eve, the First Sunday of Lent, Palm Sunday, Pentecost Sunday, World Wide Communion in October and in the summer. The elements are prepared with the help of John Somerville, Janet and Bob Jenney.

Bulletins are prepared by our Administrative Assistant, Helen Loehndorf and her helpers. Helen also prepares the slides for the Multi Media system which is operated by Dave Morris and his crew. Bill Welsh, and his helpers, run the Sound system, while Floyd Marshall video tapes the service. Bill Welsh and Dave Morris have also been available for special events, including funerals and weddings.

The Flower Committee arranges for weekly floral arrangements on the communion table and ensure these are taken to the shut-ins and others as part of St. Paul's Outreach and Pastoral Care Programs. This year they prepared the special Thanksgiving display, possible through the generosity of the Van Hoeve family, and the Poinsettia display, possible through the generosity of Anne Foster and Susan Cluett. These flowers were also taken to the shut-ins and recently bereaved.

Thank you to John Sol for faithfully updating the outside sign weekly with our upcoming Worship information.

Our custodians, Floyd Marshall and Ron Stafford work hard to keep our worship space clean and tidy.

Since the 12th century churches have used a variety of colour schemes for vestments and decorations to mark the liturgical seasons and holy days. Our choir uses the white, red, purple/blue or green collars to visually illustrate the seasons of the church year. New this year are the Antependium (hangings) for the Pulpit and Lectern designed and created by our fabric artists, Mary Johnson, Maureen Laplante, Laura Mahoney and Laurie Drew. Mary Johnson also designed and created the new blue Christmas banner.

OXFORD PRESBYTERY REPORT for 2015 ~ Mary Anne Silverthorn

Oxford Presbytery is a gathering of Ministry Personnel and Lay Representatives from each Pastoral Charge around the county. Presbytery is one of the 4 courts of the United Church. The other Courts are General Council, Conference, Presbytery and the local governing body of the Pastoral Charge.

Presbytery Meetings are held at churches throughout the County. Also included at the meetings are representatives from Camp Tanner and the UCW Presbyterial. The Presbytery meets monthly (second Wednesday) throughout most of the year.

Meetings are not held in July and August. The Presbytery Executive is made up of the chairs of teams and meets monthly on the last week of the month. Teams meet at the call of the Chair.

Rev. Jane Van Patter from St. David's United Church in Woodstock completed her term as Chair of Presbytery for 2014-2015 in September. The present Chair is **Rev. Elizabeth (Liz) Lemon** who is retired. Her term ends in June of 2016. The Chair – elect is Rev. Maya Landell – of Innerkip-Eastwood Pastoral Charge.

Each meeting is centered on a **theme**. Beginning with **dinner** (served by the members of the host church) there is always lots of **singing**, a **meditation**, **table conversation** and **group discussion**. Some of the discussions this year have centered on decisions made at General Council (GC 42) held in August 2014 in Newfoundland. (*Personally I was an elected commissioner* = delegate from London Conference for that meeting. It was very moving to be a part of this large decision making body - a body that voted for many changes in the structure of the United Church. Many of these proposed changes will come to each Pastoral Charge as remits requiring a vote at each Pastoral Charge. Stay tuned for more details during the 2016 year). During each **business** portion of the Presbytery meeting, Committee Chairs present items requiring **decisions** by the Court. Each meeting concludes with a **reflection** given by a member of Presbytery, a **closing hymn** and the **benediction**. As 2015 drew to a close many of our Presbytery discussions centered on the Syrian refugee programme and plans for Oxford's participation.

Lay reps are designated by the number of members at a Pastoral Charge (as outlined in the United Church Manual). St. Paul's is eligible for 3 lay reps. This year there have been two reps- namely: Doreen Smith and Mary Anne Silverthorn. Our clergy Rev Mark Ferrier, Rev. Maurice Francis and Rev Pat Cook also attend. Clergy attend Presbytery whether they are serving full time, part time or retired. Reports from Presbytery meetings are given at our Council meetings. If you are interested in serving as a Presbytery Lay Rep or just want further information about items you hear or read about -feel free to ask any of your reps at any time. It is always good to keep current and up-to-date. Thank you for the personal opportunity to represent St. Paul's at the Presbytery level.

BOARD OF TRUSTEES ~ John Somerville, Deputy Chair

Manse issues dominated the time and thoughts of Trustees again this year. However the outcome this year is very positive. I will first discuss minor items and then return to the manse.

The maturing 2015 GIC from the Pressey estate was reinvested for a 5 year term at 2.08%. This is in keeping with our 5 year laddering plan. The plan ensures the church always receives the top GIC rate and one fifth of the money comes due each year.

\$5,054.54 interest was generated and deposited to the general account for use of property as her will stipulates.

Insurance was \$8061 with a rebate tax of \$328 versus \$8080 in 2014. Rebates applied due to manse vacancy. Insurance also reflects a built in inflation factor of 4% approximately.

On the recommendation of Trustees, Council approved the upgrades and refurbishment of manse as detailed in last year's report. The Business Improvement Association (BIA) contracted to provide \$10,000 in grant money.

Work commenced in April and finished the end of May. Dean Masson Construction did the work. Council approved \$33,781.89 and the final bill was \$34,224.47, a minor \$442.61 over budget. Jed Drew, on behalf of Trustees and Council, spent countless hours on the project. He researched contractors, received tenders, negotiated with BIA (with Dave Morris) and oversaw the day to day work of the contractor. Jed also obtained several upgrades from Dean Masson at no charge. Thank you Jed. Your thoroughness and dedication to detail resulted in a manse we can be proud of and a job done on budget!!!!

Since Trustees have been so involved with the manse over the last few years the Property committee has relinquished control to Trustees. Communication will be maintained between the committees. A Manse Maintenance Manual has been prepared detailing all work and possible future work to manse building. Thanks again to Jed who will assume the role of Property Manager.

The Manse continued to be listed for commercial lease with RE Wood Realty. Several parties looked at the property through 2015. In November Joanna Brooks of Cup and Cake expressed serious interest. A lease was negotiated and signed for January 1, 2016 as the start date with the following terms:

5 year lease at \$1,000.00 per month.

First and Last month's rental due immediately.

First 3 months rental waived to allow time for tenant to renovate, upgrade and relocate. Upgrades include new kitchen floor, triple sink and changes to garage for storage.

Tenant is responsible for taxes, utilities and insurance (\$2,000,000 property liability and property damage).

The last item is very significant. In 2015 St. Paul's paid \$8,330.33 in taxes and \$1,305.34 in utilities (not including December). As well as receiving an income St. Paul's will save approximately \$10,000 in manse expenses for 2016. Trustees are confident Ms. Brooks will prove a reliable tenant as she currently operates an established business. The previous 2 tenants began as startups.

The receipt of \$10,000.00 grant money has been somewhat problematic. Many layers of committees and bureaucracy. The Beautification and Cemeteries Committee has given approval that the restoration work was in keeping with the historical nature of the building. The grant comes with conditions. As such the loan agreement must be registered against the title. The deed is still registered to the Methodist church. Apparently Trustees did not make the necessary changes in 1925 when the property changed to St. Paul's United. Trustees are diligently working with the lawyer to bring the legal title up to date, so the BIA grant may be released. We were hopeful all would be solved by year end, but are confident grant money will be received early 2016. St. Paul's has recoverable HST of \$2697 to help offset the cost of manse renovations.

Enclosed is a current listing of St. Paul's investments.

Thank you to all committee members for dedicating their time and talents for the betterment of St. Paul's. I am extremely pleased to present a positive report.

Excerpts from Strategic Options Review - Manse

Executive Summary - Jed Drew

This report has been prepared in order to clearly delineate and assess the longterm strategic options available to the congregation of St. Paul's United Church, Tillsonburg, with respect to the future retention and use of its Victorian-era manse.

The manse has been an issue of concern for some time, and the level of concern was certainly heightened during 2015 when the building was vacant throughout the year, as the result of the business failure on the part of the last tenant.

During this period there was no income received from the property, while the congregation was responsible for paying the insurance, taxes and utilities. Consequently, not including money spent for restoration of the exterior, partially funded under the auspices of the Town of Tillsonburg / Business Improvement Association, there was a total operating funds cash drain of \$10,622 for the year 2015 to cover taxes, utilities and insurance.

Prior to the last tenant's business demise, approval was given to restore the exterior of the building, utilizing the congregation's funds and a forgivable grant of \$10,000 from the Town/BIA. The total expenditure in 2015 for the exterior renovations to protect the building and make it more marketable was \$21,527, after accounting for the BIA grant and the rebate claimed on the HST.

It should be noted that at the time of writing this report we are still awaiting the grant money from the Town. The Town is prepared to pay, but a delay has occurred as we straighten out a residual issue regarding the proper designation of the name of the owner on the registered title to the property. This issue, which is currently in the process of resolution, stems from the fact that after the Methodist Church joined in union to form the United Church in 1925, Trustees at the time did not register the deed in the name of the United Church of Canada. We have filed the necessary documents to register the change and, when they are finalized, we will receive the grant money from the Town. As the funding will come in due time, for the purposes of this report we are assuming it is in place.

Clearly, with respect to the manse, the congregation has a major asset that requires a comprehensive future plan. This planning was broken down into two stages. First, there needed to be an assessment of the current condition of the building, with an eye to identifying future maintenance requirements. This first stage of the planning process was completed in September with the adoption of the "Manse Maintenance Manual". The second stage, this report, addresses the future strategic options available with respect to the manse.

In order to clearly identify the issues, there has been considerable discussion at both the Board of Trustees and the Church Council level and the following three options were identified as those which were to be reviewed.

- Commercial Lease of the Manse
- Sale of the Manse
- Demolition of the Manse

Needless to say, we were not in a position where we could simply sit back and develop this plan at a leisurely pace without any funds coming in. Accordingly, concurrent with the development of the long-term options the church's trustees were actively marketing the building as a leasing option in order to stem the cash outflow that occurs when the building is not actually producing revenue. This course was followed in recognition of the fact that either of the other two options would involve lengthy and onerous detailed work before they could ever become realities, even if they did prove to be the best options, and that protecting cash flow was an economic imperative.

The results of this analysis show the preferred option to be to continue with the commercial lease of the manse. This option shows an average annual positive cash flow of approximately \$9,200, while still preserving a major capital asset that has the capacity to sustain a favorable cash flow for many years in the future.

The second preferred option, although a distant second choice, is to sever the property and sell the manse. The estimated cash flow for such an option ranges from \$137,000 to \$197,000, depending upon the actual selling price and the associated costs for severing the property, and the marketing costs involved. While this amount may seem to be a potential cash windfall, it is not an option that will provide a sustainable annual income. Furthermore, selling the property has the potential of devaluing the remaining property by as much as \$100,000 as it will result in an unusual L-shaped lot for the remaining portion.

The demolition option is clearly not worth pursuing as it generates no revenue – indeed, it has a potential cost of approximately \$80,000. It would be very time-consuming and has the potential to cause considerable ill-will within the congregation and the community as it would mean that St. Pauls' would be the instigator of an action to demolish a designated heritage site.

Recommendation

Trustees recommend that St. Paul's stay the course with the commercial lease option. As we currently have a lease in place there is no implementation plan involved but the congregation needs to be cognizant of the need for us to keep up with the on-going inspection and maintenance of the manse so that we can sustain the cash flow stream into the future.

- 1) provide a consultative and supportive agency for the staff of the Pastoral Charge and for the members and adherents of the Congregation
- 2) review working conditions and remuneration for the staff of the Pastoral Charge and make appropriate recommendations to the Church Council
- 3) oversee the relationship of the staff of the Pastoral charge to members of the congregation and others
- 4) review regularly the responsibilities of all staff of the Pastoral Charge and revise position descriptions when required or requested
- 5) review and evaluate annually the effectiveness of the staff of the Pastoral Charge as these persons and positions relate to the mission of the Pastoral Charge as defined by the Church Council
- 6) review with Ministry personnel and staff their salaries, allowances and honoraria and the working conditions of the pastoral change and to make appropriate recommendations to the Council / budget committee prior to the beginning of the regular budgeting process.
- 7) conduct an annual review of the effectiveness of all ministry personnel and staff referring to the goals and objectives established by the Church council
- 8) work to resolve conflict at the earliest possible stage
- 9) liaise with the Presbytery Pastoral Relations team as needed.
