CHURCH COUNCIL ~ Submitted by Mary Anne Silverthorn, Chair

Please allow me to begin this report by reiterating Past Chair Brian's opening sentence for his report of 2016 - "this has been an extraordinary year in all respects". Although the circumstances are much different in 2018 than 2016 the words still echo true. At the conclusion of my 2017 report I suggested God had a plan for the people of St. Paul's for the future and we should move ahead with trust to follow that plan. What was that plan and where did it take us?

As winter 2018 blasted us with snow and extreme cold, Rev. Karlene and Desmond embraced their first CANADIAN winter and in true CANADIAN fashion soldiered on eagerly awaiting the April Showers and May Flowers. Rev. Karlene kept asking how many more layers of clothing she would need to get through this, however all of us including those of us born and raised in this climate survived.

During the whole time of making personal adjustments, Rev. Karlene demonstrated her true dedication to her ministry and leadership at St. Paul's. Her outstanding people skills and her infectious laugh were both inviting and contagious. New faces appeared, former congregants returned and the congregation began to grow. We transferred in members; we baptized babies, youth and adults. New programmes began and with the assistance of volunteers from St. Paul's, Messy Church began and immediately it was successful. We were reaching out to others who needed our support. Again, this outreach was demonstrated at the Christmas season as we had overwhelming response working with the Salvation Army to assist a family to make their Christmas meaningful and exciting. Rev. Karlene introduced us to Talent Sunday on two occasions in the summer months. People volunteered to share their talents. From woodworking, gardening, painting, cake decorating, needle work and music to mention a few, we were introduced to people with hidden talents. It was emotional to listen to one personal story saying the individual had never spoken in public about the work the person enjoyed doing with talented hands and knives. Minutes of the April 8, 2018 Congregational Meeting

The April 8, 2018 Congregational Meeting of St. Paul's United Church was held in the Banquet Hall.

1. Call to Order

Mary Anne Silverthorn, Council Chair called the meeting to order at 11:30 a.m.

2. Prayer - Rev. Pat Cook

3. Purpose of Meeting

To receive information and recommendations from the Trustees regarding the sale of the Manse.

Note: this is not a voting meeting. This meeting is for information purposes only, so the congregation knows the process required.

4. Information: Jed Drew and John Somerville

- Introduction of Lynne Dunlop Presbytery Representative
- Questions will be taken at the end of the presentation
- John presented three (3) options for the Manse
 - 1. Continue with the lease
 - 2. Sell
 - 3. Demolish
- John discussed what had happened at a congregational meeting on April 30, 2000. The congregation was presented with four

(4) ballots. (1) Demolish Manse (2) Lease as commercial or restaurant (3) Offer Manse and accompanying property for sale(4) Offer Manse for sale.

Carried by the majority of votes - **Demolish the Manse.**

Several months later, an offer came through to lease the manse as a restaurant. The offer was accepted. The Manse has had three (3) restaurants lease the property since 2000.

- John spoke regarding the leases St. Paul's has had with several restaurant tenants and how much money it eventually cost St. Paul's for i.e. back taxes, repairs and why we need to sell
- Jed discussed the financial implications of the Manse. Currently, the Manse provides an income of four-hundred, forty-five dollars (\$445) per year. If any major repairs are required, there will be a major financial shortfall to St. Paul's and the money will need to be raised by the congregation
- A lease preserves the capital asset, but requires continued maintenance. Sale option releases capital for investment. Demolishing forfeits all capital value of the building.
- The Human Resource and financial burden St. Paul's does not have the money or volunteers to continue the way we are.

5. Questions from congregation:

- Local Realtors The Trustees will get estimates from several realtors.
- Who gets the money when sold Lynn Dunlop informed the congregation, that two percent (2%) goes to Presbytery. The Congregation will receive the balance, but it needs to be invested and St. Paul's will only be permitted to collect interest from this investment.
- Historical designation This would stay with the building and the new owners.
- Can it be moved The Trustees did not research that situation.
- Multiple residences St. Paul's does not have the money. To convert would be beyond our financial capabilities.

6. In conclusion:

- Mary Anne promised to keep the congregation informed.
- Current tenants are aware of the proposal to sell the Manse. The current lease goes with the sale of the Manse.
- This process could take up to a year to finalize.

7. Adjournment: Meeting was adjourned at 12:45 p.m. Note: There were approximately 65 congregational and council members in attendance.

Minutes of the December 2, 2018 Congregational Meeting

The December 2, 2018 Congregational Meeting of St. Paul's United Church was held in the Sanctuary.

1. Call to Order

Mary Anne Silverthorn, Council Chair called the meeting to order at 11:30 a.m.

2. Purpose of Meeting

To call or re-appoint Reverend Karlene Brown-Palmer to St. Paul's United Church.

There will be a vote at this meeting. Rev. Karlene will be permitted to stay at the meeting until the vote, as there may be questions for her.

3. Motion to appoint recording secretary

Motion C18-01Moved by: ThelmaSeconded by: BrianResolved to appoint Debbie Beres as the Recording Secretary for theDecember 2, 2018 congregational meeting.Carried

4. History

Rev. Karlene was appointed to this Pastoral Charge in September 2017 for a two (2) year term, until the end of August 31, 2019.

Rev. Karlene, although an ordained clergy, came knowing there was a process for her to be admitted into the United Church of Canada. She had several courses to complete in addition to the interview process.

To date she has one (1) course left which begins in January. In late October, we received a letter from Rev. Lillian Roberts, the Minister of Vocations and Training from London Conference outlining the process necessary as Rev. Karlene enters the final steps toward admission to the United Church.

Rev. Karlene's interview date was November 3, 2018. She had several questions to answer and submit in advance of her interview. In addition, the Pastoral Charge supervisor for St. Paul's (Lynne Dunlop) needed to complete an evaluation and submit it to the Pastoral Relations Committee of Oxford Presbytery. Reverend Karlene shared comments from her interview with Mary Anne.

We are indeed privileged to have Karlene here at St. Paul's as our spiritual leader. The report was extremely positive and complimentary. On November 28th, London Conference Executive received the report from the Interview Board and Rev. Karlene was approved to go forward as a candidate for admissions to the United Church.

5. Updates

Rev. Karlene has kept Mary Anne informed as to the status of her Work permit and VISA and the date of expiration. To many of us it was extremely important that as Rev. Karlene applied to get those documents updated, these offices understand that even though there was an expiry date of her appointment to St. Paul's, she would be reappointed.

Tanya Cameron, Acting Personnel for London Conference and Mary Anne worked together to ensure this would happen. It became clear, St. Paul's needed to move ahead to reappoint Rev. Karlene earlier than August 31, allowing her to have the documentation required to verify that she really did have a position with St. Paul's after August 31, 2019 The initial plan was to re-appoint for another two (2) year term. However, there was concern that may not necessarily satisfy the office for the work permit and the VISA.

6. Celebration of Ministry Service

Rev. Karlene will be admitted officially and become an ordained clergy of the United Church on Saturday, May 25, 2019 in Port Elgin, Ontario.

7. Provisional Call

Following Rev. Karlene's interview in November, we found there was another option available to us - that of a Provisional Call. That is a call with no ending date attached to it. The Provision would be upon successful completion of the educational requirements and effective June 1, 2019.

Resolved, that St. Paul's United Church Pastoral Charge, Tillsonburg requests the London Conference Settlement Committee to approve the Provisional call of Rev. 10. Final

The process goes to the Settlement Committee London Conference on Wednesday, December 5, 2018, getting Karlene into the process prior to the Presbytery changes effective January 1, 2019.

OXFORD PRESBYTERY REPORT for 2018 ~ Mary Anne Silverthorn

Oxford Presbytery is a gathering of Ministry Personnel and Lay Representatives from each Pastoral Charge around the county. Presbytery is one of the 4 courts of the United Church. The other Courts are General Council, Conference, Presbytery and the local governing body of the Pastoral Charge – (St. Paul's Council).

Presbytery Meetings are held at churches throughout the county. Also included at the meetings are representatives from Camp Tanner and the UCW Presbyterial. The Presbytery meets monthly (second Wednesday) throughout most of the year. Meetings are not held in July and August. The Presbytery Executive is made up of the chairs of teams and meets monthly on the last week of the month. Teams meet at the call of the Chair.

The position of Chair of Presbytery beginning in September 2017 was held by Rev. Mark Marshall from Thamesford UC Pastoral Charge. Rev. Mark served until December 31, 2018 - the end of Oxford Presbytery.

Each Presbytery meeting is centred on a **theme**. Beginning with **dinner** (served by the members of the host church) there is always lots of **singing**, a **meditation**, **table conversation** and **group discussion**. During each **business** portion of the Presbytery meeting, Committee Chairs present items requiring **decisions** by the Court. Each meeting concludes with a **reflection** given by a member of Presbytery, a **closing hymn** and the **benediction**. Many of our Presbytery topics from January to June have included discussions about the United Church after December 2018. What would the new regions look like? What ramifications would there be to local Pastoral Charges after December 2018? We had a number of speakers "walk us" through possible scenarios for the future. With the passing of the remits at General Council in July – many questions were then answered and the real process for moving forward began. In addition, many of us were kept busy attending workshops to keep us well informed and trained as the months rolled by and December 31, 2018 grew closer.

Lay reps to Presbytery are designated by the number of members at a Pastoral Charge (as outlined in the UC Manual). St. Paul's is eligible for 3 lay reps. This year there have been two reps- namely: Doreen Smith and Mary Anne Silverthorn. Our clergy Rev. Karlene Brown-Palmer, Rev. Maurice Francis and Rev. Pat Cook (retired clergy) also attend. Clergy attend Presbytery whether they are serving full time, part time or retired. Reports from Presbytery meetings have been given at our Council meetings to keep Council informed as we move forward. Following an "Annual event for the Regions in May 2019", the process for naming lay reps from the Pastoral Charges will be somewhat different.

In May 2018 each Presbytery was asked to elect a rep to the new Regional Transitional Commission. I was elected to represent Oxford. Our work began almost immediately. We meet as a Transition Commission monthly with meetings in between as necessary. We are serving as the decision-making body until May 2019. To date we have hired staff, written governance documents, selected an office location – just to name a few. We have one Executive Minster (namely Cheryl-Ann Stadelbauer-Sampa) for three Regions and therefore when we meet with her entire area there are about 30 of us. As Region 7 --now called Antler River Watershed Region there are 9 of us who form the Transition Commission for Antler River Watershed Region. As 2019 begins, please stay tuned to learn about the changes as the United Church will "look different", "processes will be different" and "doing business will be different". Bear with us as we take time in the first few months to work out the details that might have been overlooked as we planned "for all things new".

Thank you for the personal opportunity to represent St. Paul's at the Presbytery level for the past several years. Personally, it is an honour to be a part of the Transition Commission where the action is and decisions are made and represent you at the regional level. If you have questions, please ask—I will try to answer as information is known and finalized.

BOARD OF TRUSTEES ~ John Somerville, Chair

The committee had a very busy year. I will deal with the items in chronological order.

At our request for a new appraisal of church properties the Trustees addressed the "Risk Management Report" prepared by Po Wang Chow, P. Eng., on behalf of Ecclesiastical Insurance Company. It must be emphasized the recommendations in the report are strongly encouraged, but not mandatory depending on manpower and financial reserves. There is also no timeline attached. Here is a list of the recommendations and their current status: Electrical Storage - We are now in compliance.

Asbestos - The Church and Manse have been certified asbestos free. Carbon Monoxide Detectors - Installed.

Automatic Intruder Alarm System with Remote Signaling - Much too expensive to install. The front door (Bidwell St.) is locked with entry controlled by the office and monitored by video camera.

Fire Alarms Manse - The manse is protected by smoke detectors (not monitored) and an emergency lighting system that will cut in on the loss of power. The automatic fire suppression system in the kitchen is connected to an internal alarm bell.

Lightning Protection - There is a lighting rod on dome.

Emergency Response Plan: Water Leaks - In place.

Sewer and Water Back Up - Too costly to implement.

Computer Back-Up Systems: Off-Site - Done.

The new owners of The Cup and Cake requested a reduction in their monthly rent. They are experiencing serious cash flow problems. Trustees agreed to temporarily reduce the monthly rent to \$500 a month for the next six months (February 1, 2018 to July 31, 2018). We cannot afford to lose this revenue and assume all expenses including commercial property tax, utilities and daily upkeep. At this point Trustees re-examined the Strategic Options - Manse report. An immense amount of time and human capital has been invested in the Manse since 2002, with no success. All we have to show are expenses and failed or failing ventures. It was time to take permanent action. Trustees examined all options and decided a sale was the best route to follow.

Council, St. Paul's Congregation and Presbytery agreed with our assessment of the situation. I will re-address this issue later in report.

One of the five laddered GICs from the Pressey estate matured in February. The \$34,000.00 was renewed for five years at 2.85% with Manulife Trust maturing February 27, 2023. The five GICs generated \$4,711.24 of income transferred into Estate Property acc. for the use of the Property Committee.

Enclosed is a current listing of St. Paul's Investments.

The new appraisal of church properties significantly changed valuations. The Church decreased from \$6,048,659.00 to \$5,589,981.00 and the Manse increased in value from \$620,527.00 to \$956,853.00. The insurance premiums for 2018 are as follows: Church - \$8,282.05 + \$337.57 PST Manse - \$1,242.00 + \$50.62 PST.

After Church Council and Congregational approval of Manse sale Trustees fulfilled all requirements as stipulated in the Trustee's Manual to receive Presbytery approval to list Manse for sale. On June 13, 2018 Trustees received CERTIFICATE OF SECRETARY OF PRESBYTERY TO RESOLUTION GIVING CONSENT with the following motion: to proceed with applying to the Land Division Committee of Oxford County for the severance of the manse property at 38 Ridout St. West, Tillsonburg ON, described legally as LT888-890 PL500, and any necessary minor variances and to list for Sale the Manse at 38 Ridout St. West, Tillsonburg, ON, described legally as LT888-890 PL500 with RE/MAX Tri-County Realty Inc. for a commission of 4 percent and with an asking price of \$375,000. Motion Carried. After three months on the market and very little interest shown the listing price was dropped to \$339,000. Interest perked up almost immediately with many showings and inquiries. Three offers in total were received. Trustees have accepted an unconditional offer by the buyers for closure on June 28, 2019. All the remaining conditions reside with the seller, most notably obtaining severance of the property and obtaining a zoning amendment to allow the property to be used again as a single dwelling residence in the future. Trustees are working vigorously to address the severance and zoning issues prior to the June 28th deadline. It must be noted sale is not final until approval by Presbytery once all conditions have been fulfilled.

The Manse six-month lease reduction was further extended in July for another six months until January 31, 2019. A combination of factors is making their cash flow tight, such as: loss of sublet tenants almost immediately after purchase from Ms. Brooks, minimum wage increase, cost of food inflation.

Many thanks to all committee members for a busy 2018. Special thanks to Lynne Dunlop for guiding Trustees on Manse listing and sale procedures. Special thanks to the subcommittee members, who undertook the listing, negotiations and associated matters. There has been and continues to be, an immense amount of work and detail needed for severance and related items. Much is left to be done in 2019.

Harley Jackson is retiring at the end of the year. Thanks to Harley for your valuable contribution over the years. We welcome Fran Bell to Trustees in 2019.

MINISTRY AND PERSONNEL COMMITTEE REPORT 2018 ~ Brad Bennett

The Ministry and Personnel Committee supports and supervises persons who are employed within the pastoral charge on a full or part-time basis in accordance with the constitution of St. Paul's United Church, as well as the manual of the United Church of Canada. It is therefore the M & P Committee that is the appropriate body that anyone may share any questions or concerns they may have regarding the church staff and their work.

With respect to staffing at St. Paul's, the successes enjoyed in 2017 carried over into 2018.

The most significant staffing change in 2018 came in connection with the maintenance of the church. As stated in last year's annual report, Floyd Marshall retired from his custodial position on December 31, 2017. COMMUNITY KITCHEN 2017/2018 ~ Laurie Drew, Coordinator

It is hard to know, sometimes, just which Annual Report to put our years into! Our season runs from October into April of the following year. So...our report is either early, or late.

In this season I am reporting, we had fewer guests than we have had in the past. I do know that some people have moved on to Woodstock for better services, and some people have died, and some people have become too ill to attend. I have found it a hopeful sign that we don't have many new guests, in as much as I hope that there are more jobs available and people don't need us as badly.

Having said that, we still served 1,015 meals last season, as well as sometimes feeding Messy Church attendees. Our ministry of serving God by serving others also means serving each other!

We received \$4,879.13 as donations, and spent \$7,180.32 on food and supplies, for an average cost per meal of \$7.07 per meal. This number continues to rise, as food costs go up.

I am really grateful for the assistance of the other Team Leaders (Dave Morris, Jed Drew and Vermell Stevens of St. John's), as well as the talented, dedicated teams of volunteers who cheerfully show up at all times. Thank you! I am also thankful for you, the donors and cheering section – thank you, too!

PROPERTY COMMITTEE ~ Dave Morris, Chair

The Property Committee has the responsibility of general oversight of the Church edifice and grounds delegated to it by the Trustees and serves as the working arm of the Trustees. Duties include maintaining physical condition of the building, grounds and contents, collaborating with appropriate groups in maintaining property and inventory. Other duties include developing a five-year maintenance program as well as a list of all physical assets, maintaining building security and safety, submitting all fund-raising plans to Church Council and arranging volunteer work parties.

Air conditioning was added to the Sanctuary this year thanks to generous donations from the congregation. These units cool, dehumidify and provide supplementary heat if required. A bonus benefit is the Wi-Fi enabled thermostats which allow the sanctuary temperature to be monitored off site all year long.

Kitchen improvements were also made during the year. A new commercial replacement fawcett was installed in the main kitchen thanks to AOTS. The commercial fridge was also replaced thanks to the UCW. Modifications were made to the Friendship Room Kitchen cupboards installing drawers in place of shelves. Thanks to Harley Jackson for his carpentry expertise.

LED replacement bulbs were installed in the Sanctuary and other areas of the Church. Thanks to Desmond for the installation. Bulbs were purchased under a Hydro subsidy program at a greatly reduced price which should result in lower hydro bills.

New light weight extruded plastic tables were purchased for the banquet hall from the final insurance settlement from the 2016 "flood". These are much easier to set up and take down than the old wooden tables.

Miscellaneous work was carried out as well by volunteers including painting, gardening and grass repair to the grounds. Church Security Policies were reviewed and recommendations made to Church Council.

Ron Stafford retired from our custodial staff in November. Thanks to Ron for his diligent work this past 4 years. He along with Desmond Palmer have kept the church in great shape and provided excellent service to all the users of the facilities in 2018. Desmond has picked up Ron's hours and has continued the high standards that have been set with past custodial staff.

Thanks to all of the Property Committee members- Margaret Meerveld, Ron Stafford, Bob Jenney, Barb Aubrey, Colleen Martin, Reg Butcher and Harley Jackson - for their dedicated service to St. Paul's. Harley will be leaving the Committee in 2019 and we thank him for all his hard work.

Our church facilities were used by a variety of community groups, including Guiding groups, Canadian Cancer Society, Salvation Army Kitchen projects, Heart and Stroke Association, Community Kitchen and Sea Scouts.

The church supported Back Packs for Kids, Celebrate Tillsonburg to help communicate our work in the community, Food Bank with monthly drive, the Salvation Army Kettle Drive and Adopt-A-Family at Christmas partnered with the Salvation Army.

Each and every day someone's life is changed in Canada and around the world through the generous giving to Mission and Service. The total fund for Mission and Service in 2018 was \$32,744.50, which included \$5,000.00 from the UCW. Donations to World Change totalled \$327.00. The Minute for Mission in the bulletin highlighted the work in the world. The 'Did You Know...?' featured service locally and abroad.

The special offering supported the following projects: Camp Tanner, Canadian Foodgrains, Community Kitchen, Domestic Abuse Service Oxford (DASO), Helping Hands Food Bank, Salvation Army Tillsonburg, Sakura House Oxford and United Church of Canada World Development Fund. The amounts are detailed in the Financial Statement.

Non-Monetary collections continued: Canadian Tire money for Camp Tanner, pop-can tabs for Kids 4 Wheels, Campbell soup labels for World Mission of the Deaf, used stamps for Leprosy of Canada, and Cowards perks for projects. All containers are located in the rotunda.

Thank you to all for all your gifts shared so generously, sometimes quietly but always enthusiastically, in the service of others.

MESSY CHURCH ~ Norma Collis

Our "inaugural" session introducing Messy Church to the Community was held on February 17, 2018.

The program has run continually since then on the third Saturday of the month. This included the summer months of July and August. The number of participants runs between 22 - 44 people and includes babies, toddlers, and school aged children right up to and including young teens. In total 75 different people have been introduced to the Messy Church concept in the past 11 months.

A different theme is chosen each month with an average of 10 activities offered at various levels of difficulty.

Our Messy Church volunteer team is comprised of 15 people with 8 of these coming from the St. Pauls family while the remainder comes from the community at large. We often have a "Guest Crafter "who shares their expertise for just one session.

The "order of service" follows the same format each time. Arrival of the participants begins at 10 a.m. and there is juice, coffee and a snack waiting for these people as they decide which crafts they would like to do. People move freely from craft to craft as the parents work along with their children on the activities of their choice. Some of the activities have given our participants an opportunity to view various parts of our church building and to be included in events like our Church service in the park and the Frosty Fair Bazaar.

Around 11 a.m. everyone forms into a large group and enjoys a "worship" time of music and a story.

At 11:30 a.m. we all move to the dining tables to enjoy a full meal together. Some of these meals are prepared by the Community Kitchen teams and some by members of the Messy Church team. The cost of the meals averages \$3.00 per person.

Our initial startup funding came from the Oxford Presbytery "Possibility fund" the program continued to run thanks to an inclusion of the initiative in the general church budget, a donation from the UCW and private donations of cash and goods.

The average monthly cost of the program is \$150.00 per session.

This cost is in line with other Messy Church programs offered throughout Ontario.

The feedback from our attendees is very positive and makes each event very rewarding for all of us involved.

I am pleased to report a successful year at St. Paul's – monetarily we finished payment in full on two large projects (The Organ Refurbishment and Dome Repair). We also paid for

the Sanctuary Air Conditioning in full and paid back to Presbytery the Loan of \$13,440.00 in full. Thank you to the Congregation for your very generous donations. The good news is that we did this with very little effect on our weekly givings. This allowed us to cover all other expenses at our budgeted levels. TREASURER'S REPORT ~ Laurie Drew

As most of the members of the congregation likely are aware, the United Church of Canada has changed its organizational model. We no longer have any Presbytery or Conference in the church, but now have 16 new regions.

As a result of these changes, we no longer pay fees to Presbytery for administration purposes for Oxford or London Conference. Also, funds are no longer drawn from Mission and Service donations to pay for governance and administration costs for General Council. Instead, following a new funding model, we will pay fees directly to United Church of Canada (which then will give grants for operating and Mission and Service to our new region, Antler River Watershed Region) in much larger amounts than we have paid before. Our new total assessment is based on 4.5% of our income (excluding M&S income, HST Rebates, Property sales and Major Capital Fundraising). Last year, we paid \$7,200 for fees to Presbytery, and our new assessment is \$14,793 for the New Year. General Council has allowed us to gradually increase our totals to reach this amount. Our payment for 2019 is \$7,950, followed by \$9,744 in 2020, \$12,180 in 2021, then the full amount in 2022.

One of the important items to take away from this reassessment is that our Mission and Service donations go completely to mission work, meaning that the church will be able to spend more on mission and ministry.

I wish to thank all members of Finance Committee, Ron Wycherley, Deb Wycherley and Doug Franklin, as well as Assistant Treasurer Doreen Smith, for all their willing and able assistance in 2018. I also thank Helen Loehndorf, who works away in the background to make everything easy!

I also thank our auditor, Paul Hanson for once again stepping in to ensure our books are correct.
